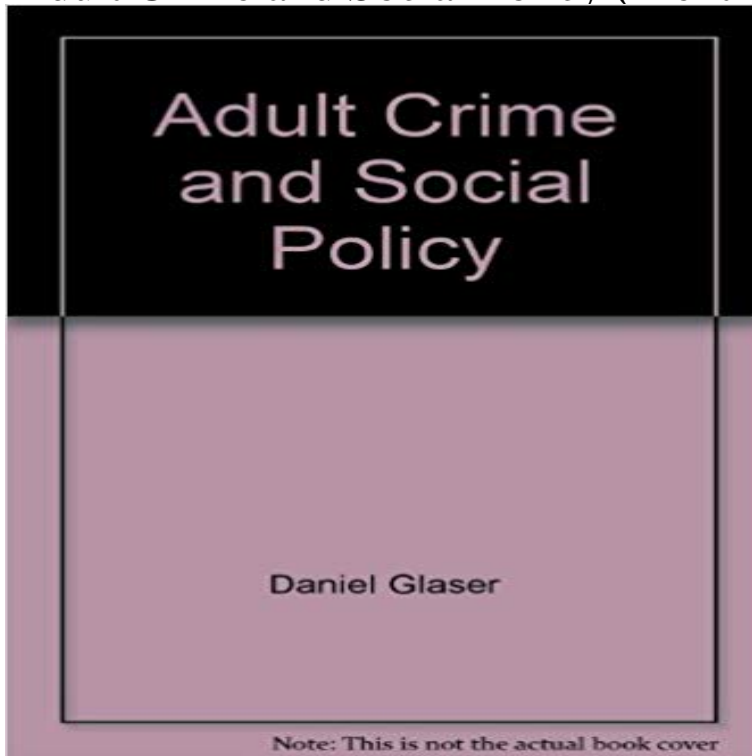


Adult Crime and Social Policy (Prentice-Hall series in social policy)
