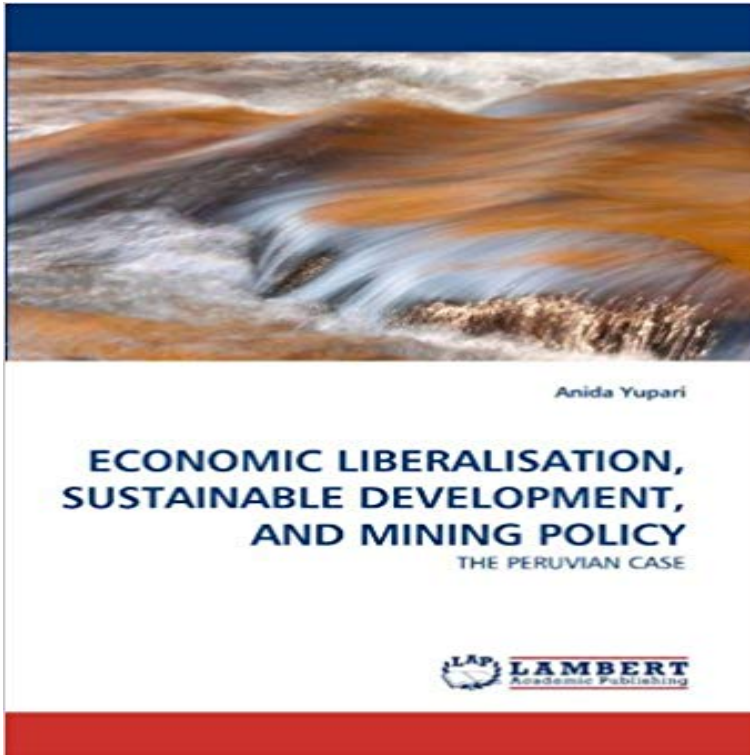


ECONOMIC LIBERALISATION, SUSTAINABLE DEVELOPMENT, AND MINING POLICY: THE PERUVIAN CASE

The new pro-development perspective of international policies during recent years has strongly influenced the evolution of mining policies and related laws. Presently, mining sector is keenly scrutinised for the way that it contributes to achieve MDGs and reduce poverty in natural resource-rich countries.
