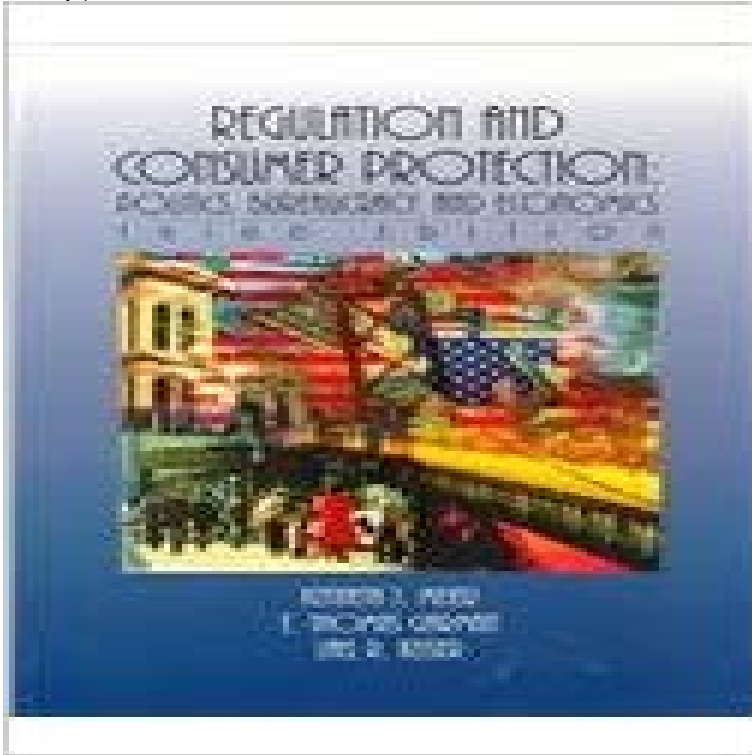


# Regulation & Consumer Protection: Politics, Bureaucracy & Economics
