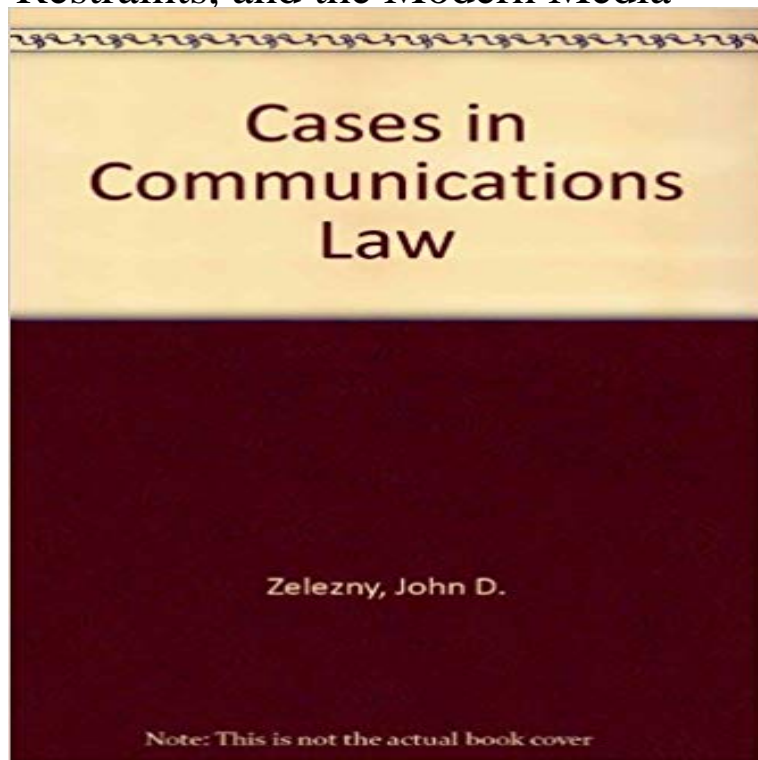


## Cases in Communication Law, 2nd for Communications Law: Liberties, Restraints, and the Modern Media
