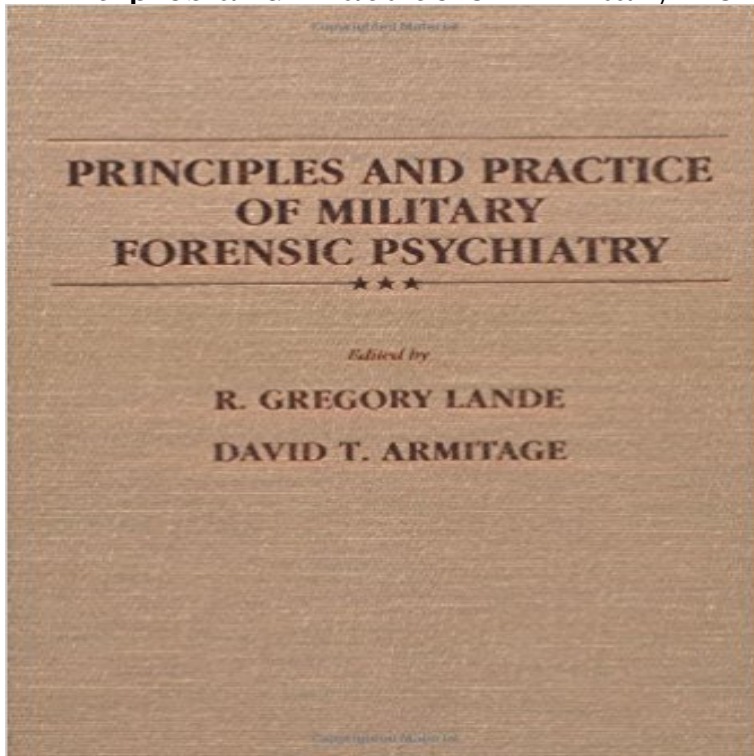


# Principles and Practice of Military Forensic Psychiatry
