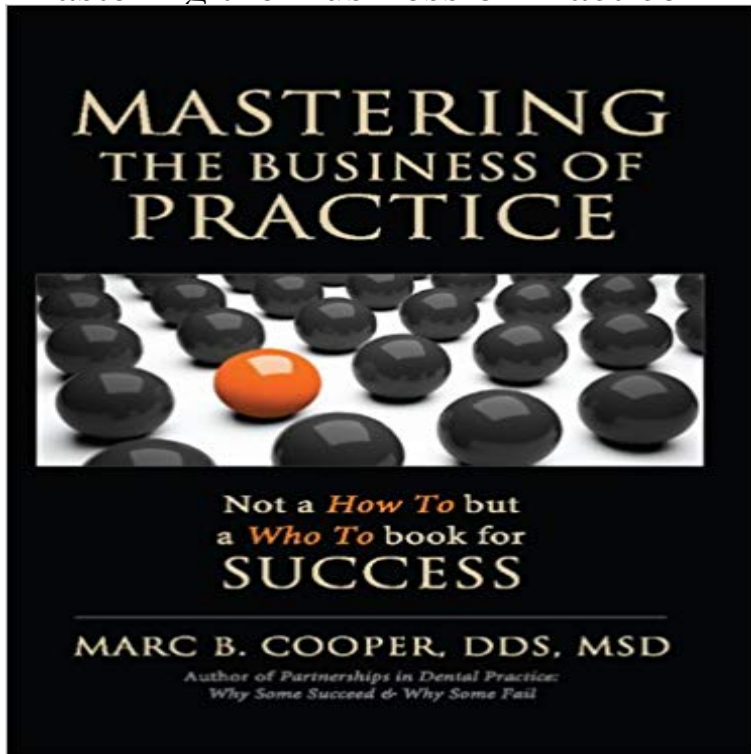


Mastering the Business of Practice
