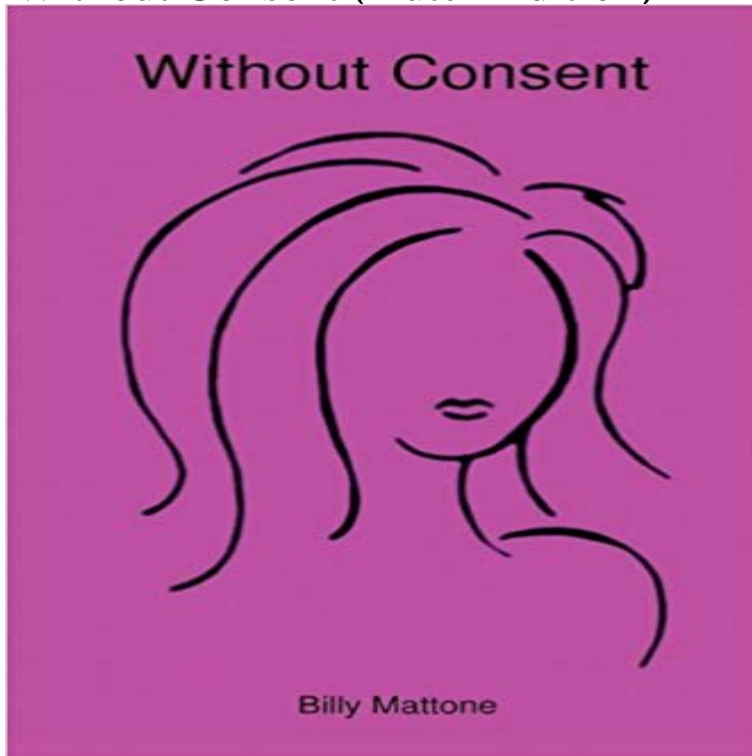


Without Consent (Dutch Edition)
