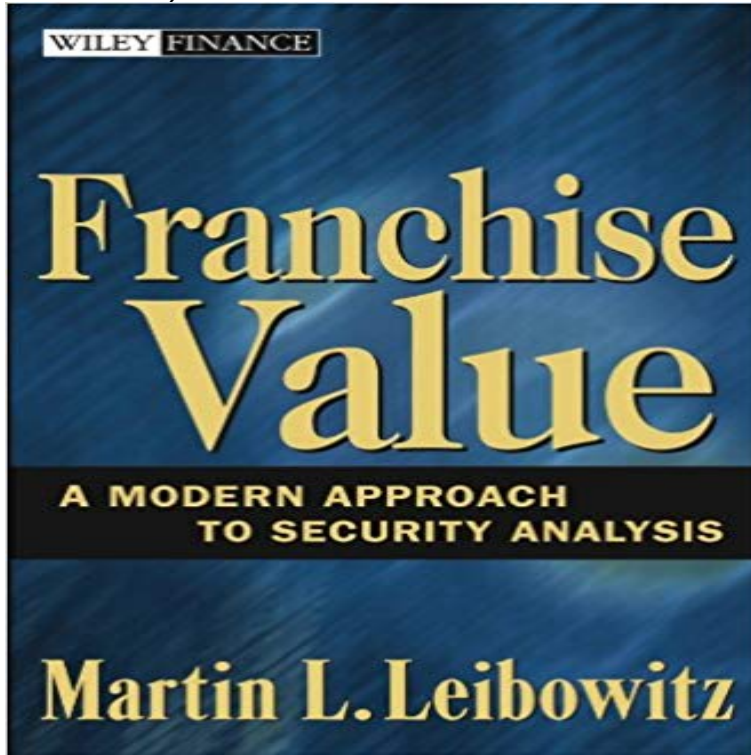


Franchise Value: A Modern Approach to Security Analysis (Wiley Finance)
