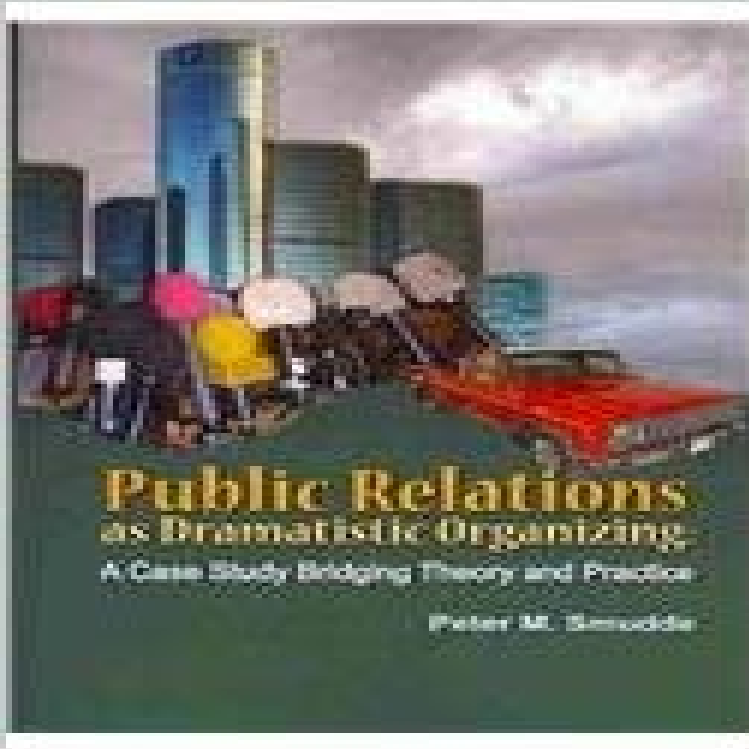


Public Relations as Dramatistic Organizing: A Case Study Bridging Theory and Practice (The Hampton Press Communication Series: Communications and Social Organizations)
