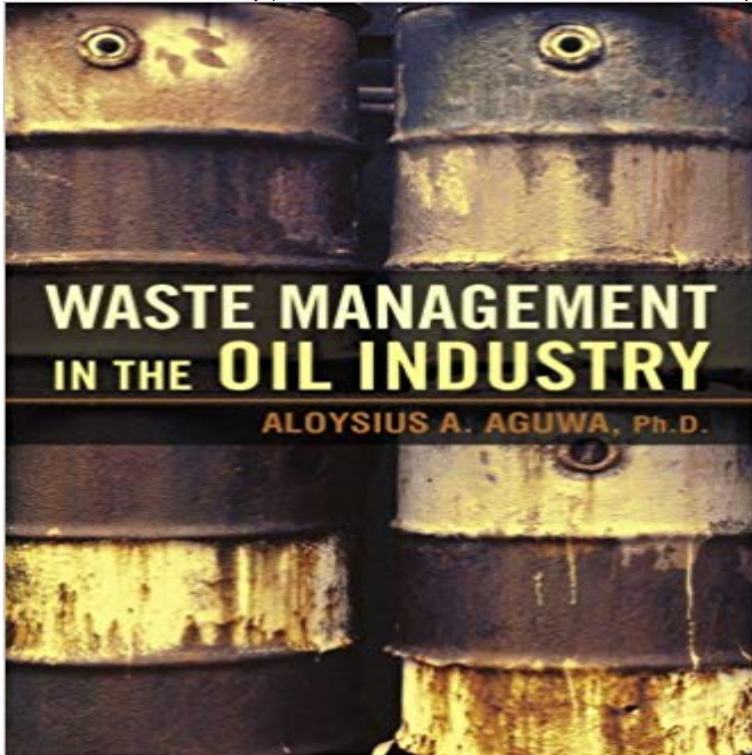


## Waste Management in the Oil Industry
